The Master of Laws program is designed to equip practising lawyers and law graduates with an advanced understanding of the law to meet the challenges of the dynamic workplace.

The flexible course curriculum gives you the freedom to personalise your education – you can choose a specialised area of the law or broaden your knowledge across a diverse range of subjects including commercial law, government regulation, resources law and a range of public and private international law areas.

Course structure

The Master of Laws consists of 48 credit points, comprising eight units that are six credit points each, which equates to one year full time or up to four years part time. Students can choose to group their options in a distinct specialisation or they may prefer to spread their choices out over a variety of different subjects in law. The LLM can be tailored to suit all needs.

Study options

The Faculty of Law offers subjects either intensively or during the regular academic semester to accommodate different study preferences. Intensive units are subjects delivered in a shorter time period than the regular semester; we also offer flexible part time and full time study options.

Admission requirements

Admission to the Master's degree is assessed on the academic performance of a prospective student's previous degree. We expect a GPA of 5.5 on the 7 point scale, a WAM of around 60%+ average (or international equivalent) and take into account any relevant work experience.

International applicants must be able to demonstrate satisfactory performance in a UWA-approved test of English with a score equating to an IELTS score of 7.5, with reading and writing at 7.5 or over and no other band under 7.0.

Applications

The Master of Laws accepts applications all year round, but for those students who prefer to begin studies in sync with the regular semester applications are due as follows:

- ^y By the end of January to begin their studies at the start of semester one.
- By the end of July to begin their studies at the start of semester two.

The intensive units require application submission four weeks prior to the advertised start date.

Domestic applicants are welcome to apply by completing an application form and mailing to the Faculty of Law.

□ International

International postgraduate applicants must complete the postgraduate application form and submit to an authorised UWA overseas representative or directly to the UWA international centre.
